Other RN job functions include performing diagnostic tests and analyzing results, operating medical equipment, administering medications, recording patients' symptoms and medical histories, and assisting with patient rehabilitation and follow-up.

A certified legal nurse consultant is a registered nurse who uses expertise as a health care provider and specialized training to consult on medical-related legal cases. They assist attorneys in reading medical records and understanding medical terminology and healthcare issues to achieve the best results for their clients. The specialty is a relatively recent one, beginning in the mid-1980s.
