
World's Largest Muslim Group embarks on Halal-Certified ARAH GLOBAL App and Digital Asset: Islamic Modernization for Global Unity

The ARAH app and coin will provide competitive advantages due to the size of the membership base which is proven economies of scale for attractive discounts for the benefit of members. The app will be made available in stages.

What is Blockchain?

Blockchain is a decentralized network of computers that records and stores data to display a chronological series of events on a transparent and immutable ledger system (unchangeable collection of accounts). Decentralization is the process by which the activities of an organization, particularly those regarding planning and decision-making, are distributed or delegated away from a central, authoritative location or group, putting power into the hands of the people.

ARAH GLOBAL Coin

Being the official token of the ARAH app, the ARAH coin can be used for payments for selected goods and services. The total supply of coins will be limited to 100 billion with 50 billion coins pre-sold to 50 million members (1000 coins per member with a total value of 10 Singapore dollars for each member) at the early-bird price of 0.01 Singapore dollar, a safe-haven currency. The smallest denomination for

ARAH coin is 1 coin with zero decimal points. The total initial network value of ARAH coin is 1 billion Singapore dollars. The remaining 50 billion coins will be for sale to other NU members and the public who want to reap the same benefits.

The ARAH coin will reside on Waves blockchain which is in the process of being interlinked with other major blockchains such as Tron, Ethereum, Binance, Singapore dollar blockchain and others, forming the world's largest multi-linked blockchain. In the near future, there will be plans for ARAH coin to be made available on DBS digital exchange when DBS announces details.
