Growth has been fuelled by the burgeoning MENA e-commerce market.

The growing relationship between China and the Middle East is also driving new cross-border partnerships to help facilitate cashless payments between the two economies.

The collaboration between Telr, Aleta Planet, and UnionPay gives Middle Eastern merchants access to billions of cardholders who are making payments with UnionPay cards and it also gives UnionPay Cardholders the ability to use their cards at the merchants in the Middle East. UnionPay is one of the most popular payment methods among Chinese consumers. Globally, the company has issued cards to users in 68 countries and regions.
