
## The first ever complete NFT video game on Mintable.app

Covid-19 has only made the Alzheimer's crisis more exacerbated. JUDGE, also known as Stephen Judge, has dealt with this on a personal level. "It has been tragic to watch a family member I love slowly deteriorate and forget her life. Her reality has become distorted. She often sounds like a tape recorder reciting key moments of her past over and over as if desperately trying to hold on what's left of her memory." JUDGE hopes that Echoes Of Me can spark conversations between generations and bring this disease into the spotlight.

JUDGE will donate 20% of the proceeds from the sale of Echoes Of Me to the Alzheimer's Association to help find a cure for Alzheimer's.
