Having earned the distinguished credential of Registered Physician in Vascular Interpretation (RPVI), he is board-certified in vascular surgery by the American Board of Surgery (ABS). The ABS is an independent, non-profit organization located in Philadelphia, Pennsylvania, founded for the purpose of certifying surgeons who have met a defined standard of education, training, and knowledge.

In addition to being a Fellow of the American College of Surgeons (FACS), Dr. Tulsyan is affiliated with the American Academy of Family Physicians, the Society for Vascular Surgery, and the ABWM Foundation.
