The Company distributes nutraceutical products from its integrated online web store. Customers who set up accounts can easily track orders, receive promotional specials and update key information related to deliveries and payments. Notably, one of the company's products has gained both retail and on-line consumer brand recognition as one of the most single effective male enhancement products in the world, which is known as "Hard Steel". The product is sold at hardsteelusa.com and has received raved reviews and quickly built a dedicated consortium. With more than 15,000 customers placing pre-orders of the 10 count Hard Steel prior to launch, the Company has also been able to expand its brand in Australia and the UK through dedicated product distributors.

<u>Christopher Ingram Gwinnett County</u> is a consummate business professional and entrepreneur who continues to diversify and apply his 25 years of business experience to almost any discipline. In October of 2014, Christopher Ingram formed Ingram Capital Group as an acquisition for South Texas Implement Corporation or STIC. Upon qualifying ICG to Agricore John Deere Corporation for the acquisition of 38 Dealerships, Mr. Ingram was credited with uncovering potential financial mismanagement and the subsequent acquisition was halted saving the investment group more than \$35MM in the transaction.

Over the past 20 years, Mr. Ingram has launched several start-ups, completed several acquisitions, secured debt & equity facilities, and customized managerial and operational matrixes in middle-market companies while defining and leading towards real and intrinsic value.

In June of 2010, Mr. Ingram accepted an invitation to join a partnership group in OpenVision Networks, Inc. The Company operated a video content streaming platform that had an intuitive user interface, original content, and great technology and it sought to compete with Netflix, Hulu, and other streaming services. Mr. Ingram provided day-to-day leadership in the Company while strategically positioning the business as an attractive acquisition candidate through controlled content implementation, operational matrix, and improved valuation.

In 1989, Mr. Ingram, 20 years old at the time created the CX-24 Home Plaque Removal, an electronic toothbrush that gained patent pending status in 1990 and reached the market in 1991. In 1993 Mr. Ingram launched Continental Financial Group (CFG), an agency specializing in the recovery of non-performing loans, bank primary charge off accounts, and subrogation portfolios between hospitals, physicians, and insurance companies. CFG was absorbed in 1997 through a Management Buy-Out.

In early 2001, <u>Christopher Ingram Atlanta GA</u> was asked to join IPA Consultant Group as a Senior Business Analyst in Chicago, IL. The firm is still the largest independent consulting firm that specializes in change management, system customization, acquisitions, valuations, and capital formations. Mr. Ingram left the Company in 2003 to launch Nortech Communications, which succumbed to a market squeeze due to an unexpected shift in low voltage demand, voice over IP, and system integration. After identifying an opportunity in 2003 from the popularity of South Beach Diet, Atkins Diet, and others, Mr. Ingram launched Natures House, Inc., an All-Natural Product Distribution company with internal bottling solutions and private label packaging for other distributors.

The Company's core product was called Herbalxx Teas and was offered in major retail stores across the country. Natures House grew organically through several acquisitions and in 2008, the company merged with The Outlet Nutrition Company. Outletnutrition.com was an online retailer with over 5,000 different products in the area of health & vitality (i.e. vitamins, supplements, men's health, women's



health, etc.) through 2010.

In 2009, <u>Christopher Ingram Forsyth County</u> was also accepted by MasterCard International as a prepaid card distributor and granted national territorial rights to launch the very first environmental awareness prepaid Mastercard. The Company, Prepaid Card Services, Inc. is most highly recognized for its widely popular prepaid card promoting a cleaner environment.

Christopher Ingram is the former host of "Global Business Talk" on "The Chris Ingram Show", live Monday-Friday 8 am-10 am EST on OVNtv Channel 53, and has self-published a book entitled "Market Turbulence" on Amazon.
