Canada provides an opportunity for their citizens/ permanent residents to settle along with their families. A **spouse visa in Canada** is one such way to settle down with the family. Canada has a program called spousal sponsorship that can help in bringing one's spouse to the country. This program is offered under family sponsorships.

Under the spousal sponsorship program, Canadian citizens/ permanent residents can-

- Sponsor the permanent residency stay of their spouse or a common-law partner
- Sponsor the permanent residency stay of dependent children

Unlike the other immigration processes to Canada, the spousal sponsorship program does not follow the point system. The application is generally processed around a period of twelve months. The sponsor should be in a position to financially sponsor the permanent stay of their common-law partner or spouse.

The sponsor is asked to sign a legally binding contract. This contract would be with the Immigration, Refugees, and Citizenship Canada government department, also known as the IRCC. Through the

spouse visa Canada, one's spouse can become a permanent resident of Canada along with their partner.

Categories Under the Spousal Sponsorship Program

The following are the categories available under the Canadian spousal sponsorship program-

- Outland Sponsorship
- This is for when the spouse is residing beyond the border of Canada.
- Inland Sponsorship
- This is for when the spouse is currently living in Canada for a temporary period.

Characteristics of a Spouse Visa Canada

There are some general characteristics that are required for spousal sponsorship. These characteristics apply to both married and unmarried partners. They are listed as below-

- There should be a mutually agreed commitment.
- The partners should be in an intimate relationship.
- The partners should be dependent on each other for emotional, financial, physical, and social needs.
- The existing relationship should be a permanent and a long-term one.
- If the partners have children, they should take care of them equally.

Requirements for a Spouse Visa Canada

The following are the requirements for a spousal visa to Canada-

- The applicant (sponsor) should be above the age bracket of 18 years.
- The applicant's spouse should be a resident of Canada. They should be living in the country or should be planning to return to Canada.
- The applicant should not have any criminal records on their name.
- The applicant should not be an imprisoned person.

Application And its Submission

Three general cases occur during the submission of the applications. They are briefly discussed below-

- Submitting the application is the first step. Both the open work permit and permanent residence sponsorship applications can be submitted together. This can be done in CPC-M - Case Processing Centre - Mississauga.
- If the permanent resident application is not approved, the open work permit can be submitted as a hard copy. The submission can be made in CPC-V in Alberta- Case Processing Centre - Vegreville.
- If the permanent resident application is approved, the open work permit can be submitted online or hard copy. The hard copy can be forwarded to CPC-V, Alberta.

Documents Required for a Spousal Visa to Canada

The following are the required general documents to apply for a spouse visa to Canada-

- Evaluative record of the sponsorship
- Certificate authenticating the relationship of the partners (like a marriage certificate)
- Marriage invitation copy along with wedding photos
- Birth certificates or certificates attesting adoption of children
- Government-approved marriage registration

Any two of the documents from the following are asked by the authorities-

- Property documents that have the names of the partners
- Joint bank account details
- Utility bills like electricity bills that have the names of the partners
- Insurance documents of a car
- IDS issued by the government
- Tax forms that indicate that the partners share the same address

In the case of common-law partners, a marriage certificate is not necessary. Instead, they can establish their proofs of relationship via the following documents-

- Shared bank account details
- Property documents showing that both of the partners own it
- Cohabitation records like rental documents
- Phone calls
