Professionally, Dr. Bussian is an active member of the American Academy of Dermatology, the Women's Dermatology Society, the College of American Pathologists, and the American Society of Clinical Pathologists, among others. She is also a past President of the Alabama Dermatology Society.

Dermatopathology is a joint subspecialty of dermatology and pathology or surgical pathology that focuses on the study of cutaneous diseases at a microscopic and molecular level. It also encompasses analyses of the potential causes of skin diseases at a basic level. A dermatopathologist is a highly trained physician who specializes in diagnosing disorders of the skin under a microscope.
