India eVisa Application

New Delhi, Delhi Oct 6, 2022 (IssueWire.com) - Indian e-Visa is India's program of electronic visas that are given to foreigners who are planning to enter the country. At the time of this electronic travel authorization's launch, the US was a launch member, so it allows some perks and benefits for the citizens of the USA. When applied, the application does not need more than 48 hours to be processed and granted to US citizens. The application website is easily accessible and requires minimal documents that can be completed within 5 minutes.

To be eligible for the **INDIAN VISA FOR US CITIZENS**, the applicant requires a standard passport, not an Official or Diplomatic one, and must have a validity of at least 6 months from the date that the applicant is entering the country. The US citizens can only use this Indian e-Visa 3 consecutive times in one year. The application must be done at least 7 days before arriving in the country. The applicants must also have a return ticket for the visa to be granted. The process requires minimal information such as contact details, passport details, employment details, and a valid payment method. The visas can be for three purposes; a medical visa, a business visa, or a tourist visa. For **INDIAN MEDICAL VISA**, applicants must submit a letter from the Indian Hospital the visitor would be seeking treatment with its Official Letterhead. The traveler also will be required to answer any questions about the Indian Hospital they would be visiting. For details, visit: <https://www.india-visa-online.org/types/india-medical-visa/>

There is also another option for an e-Visa for **INDIAN MEDICAL ATTENDANT VISA** which is granted for only 2 members against one medical Indian e-Visa. Both the medical Indian e-visa and the medical attendant Indian e-visa, are valid only for 60 days from the date of entry. Apart from the medical e-Visa and tourist e-Visa, visitors can also apply for an Indian business e-Visa. This visa will give you a continuous stay in India for 180 days.
