

## My MMJ Doctor has made the process of getting a Maryland Medical Marijuana Card Easier - Learn How

Most people applying for their first Maryland medical marijuana card find the process confusing. We will guide you step by step through the procedure to eliminate this confusion and assist you in receiving your medical marijuana card.

Beginners candidates often misunderstand medical professionals' recommendations for a medical marijuana card. We will guide you step by step through the procedure to eliminate this confusion and assist you in receiving your medical marijuana card. You should be aware that obtaining a medical marijuana card in Maryland is simple but time-consuming before starting the application process. The time it takes to receive a mmj card for new and renewed patients could be close to 50 days.

In Maryland, Medical Cannabis Commission is responsible for controlling all aspects of marijuana use, including possession, consumption, and growing. If you want to buy medicinal marijuana from any dispensary, you must get their permission to do so.

The MMCC has developed a list of [qualified medical conditions](#) in order to assure the safe use of marijuana. It would be better to get started if you have been identified as having at least one qualifying medical condition. You can apply for the following positions if you believe you have a good chance of being qualified:

- A Doctors' Recommendation

An essential document you will need to begin the process is a doctor's recommendation. Although it is not a medical marijuana card, it will assist you in obtaining one. The caveat that "not every doctor can give you a recommendation" should be noted. For that, MMCC has granted permission to several suppliers. Before providing you with a suggestion, the doctor must first diagnose your medical condition and determine whether it meets the qualifications.

You are given an MMCC Patient ID by the Maryland Medical Cannabis Commission. While determining whether you qualify for treatment, the doctor also uses this ID. With this ID, the doctor uploads your referral to the MMCC registration portal. your temporary ID card will be generated after that.

Only current Maryland residents are eligible to obtain a Patient ID. Visitors are not currently permitted to purchase marijuana in Maryland.

If you are not in contact with a doctor who is recognized by the state, getting a reference from the doctor could be a major issue. Work with My MMJ Doctor if you want to avoid trouble. We assume all responsibility for putting you in touch with a physician approved by MMCC. You can start by taking these actions.

### First Step: Submit Online Application

By providing your information on our online appointment form, you may begin the procedure.

### Step 2: Connect to the Internet

The link to attend the session and the appointment times will be sent to your email. Connect with the doctor via the link to schedule an evaluation.

### How Should I Go About Registering with MMCC?

You can follow the same procedures listed below to start using MMCC. If you have any questions, you can view the following video.

1. Open your web browser and go to the MMCC registry portal.
2. Then, click "Create Account" next to the patient's name.
3. Check your email address right now.
4. The MMCC will send an account verification link to your associated email address when you have finished and submitted an online application form to register as a patient.
5. To validate your account, you must now click the link in the verification email.
6. In the event that the user neglects to complete this step, the application procedure will not be finished.
7. The applications will subsequently be examined by the MMCC.
8. Also, a follow-up email informing you of the outcome of your application will be sent to you.
9. As soon as your doctor issues a written certification for medicinal cannabis, make sure to save the approval email for your records because it contains your user name and MMCC patient ID number.
10. Once your application with MMCC has been granted, you may also name a carer. But, if you are unable to use medical marijuana due to a disability, you may do so. Before being chosen by a patient, a carer must register with MMCC.
11. You must see the certified medical professional after receiving the approval in order to get a valid certification.
12. Print your MMCC patient ID card once the entire process has been completed to gain authorization to buy Medical Marijuana from state-licensed dispensaries.
