
## Travel effortlessly and in a Hassle-free Way with the Canadian eVisa

As part of Canada's joint agreement with the United States for securing both borders, the country has started a visa waiver program from 2015 onwards. This Canada eVisa is different from the traditional paper visa which requires the applicants to visit the nearest embassy to apply. This can be applied online, on the website as well as collected in the given email addresses. The **CANADA VISA APPLICATION ONLINE** is easy, simple, and quick. The entire application process can be completed within just a few minutes, in only 3 steps. The first step includes submitting the applicants' personal information such as Gender, Place of Birth, Marital Status, Family or Last Name, Date of Birth, Email Address, etc. The next step is to review the details and pay for visa fees. In the last step, the applicant will receive the visa at the submitted email address. The Canadian ETA (Electronic Travel Authorization) is given for three purposes of visits; tourism, business, and transit visits. The

**CANADA VISA ELIGIBILITY** is for 5 years and the travel authorization will be linked with the applicant's passport. Travelers from the eligible countries are advised to apply for the Canada eTA online minimum 3 days in advance of the date of arrival. A very common **CANADA VISA FAQ** includes whether dual citizens can apply for the visa waiver program. The answer is dual Canadian citizens can no longer travel to or transit through Canada by air with a non-Canadian passport. To get the **CANADA VISA FOR GERMAN CITIZENS**, travelers would need a valid passport, minimum personal information, and a valid payment method, along with an electronic device to apply for the visa.
