"My wife, Melissa, saw how deeply the job was affecting me and encouraged me to find a new direction," Lamoureaux shared. "Listening to her was the best decision I ever made."

This pivotal moment inspired him to shift his focus to higher education and civil rights compliance, where he could continue serving others in a new capacity. Lamoureaux earned a Master's degree in Organizational Leadership, maintaining a 4.0 GPA, and was honored with the Rex Andrews Police Scholar Award for his achievements.

As the founder of CIXE, Lamoureaux brings his investigative expertise to Title IX cases, specializing in sexual harassment, dating violence, and stalking. With over 1,000 investigations conducted, he has become a trusted advocate for fairness and accountability.

"I noticed a real lack of affordable, expert-level external services for organizations," Lamoureaux said. "Through CIXE, I wanted to provide accessible, high-quality support for civil rights and Title IX concerns."

Lamoureaux's impact extends beyond investigations. He has trained over 1,000 faculty, staff, and students on critical topics like consent and sexual assault prevention, focusing on improving campus collaboration and trust.

Balancing his demanding career with family life is a priority for Lamoureaux. Married to Melissa for over 22 years, the couple shares two daughters, Bella and Dani, who are both attending Auburn University. Lamoureaux credits his faith and family as the cornerstones of his success, saying, "I've learned to think of others first and dedicate myself to serving both my family and my community."

Lamoureaux's dedication to service is evident in his extensive volunteer work, which includes coaching football, organizing charity events, and counseling for mental health services. At CIXE, he continues to mentor professionals in the field, fostering collaboration and innovation among Title IX and civil rights advocates.

"Success to me is creating safe environments and helping my colleagues serve their communities better," Lamoureaux concluded. "We should all be striving to learn, grow, and make a positive impact."
