Understanding How Livesign Functions - A Game changing method for Digital Identity Authentication:

Livesign's platform provides a powerful, dual Verification of Identity (VOI) and Verification of Signer (VOS), to make sure that each signature is authentic by connecting the signer directly to their government-issued photo ID. In real-time, the platform biometrically connects the signer to their ID, verifying that they are the person they assert to be. This innovative method makes it possible to authenticate legal documents remotely, without physical presence.

Livesign's process begins with a link to instructions sent to the user via email or text message. Then users are directed to scan the RFID chip integrated into their passport or government-issued ID. This chip contains the key component of innovative identity verification, securely storing encrypted data that has an individual's full name, date of birth, nationality, and a high-resolution photograph. Livesign then verifies that the chip has been cryptographically signed by the issuing government and ensures the chip has not been tampered with or cloned.

Upon completing the ID scan, users are prompted to take a selfie. This selfie is then compared biometrically to the verified government-issued ID, confirming that the person signing the document is the correct individual. The biometric verification procedure involves testing for components such as liveness detection to know that the person is both genuine and the correct individual at the time of signing.

Moreover, Livesign captures the essential details such as name and date of birth from the ID to prevent common user mistakes, such as misspellings, incorrect signatures, or outdated information. The extra

layer of verification helps decrease expensive mistakes that could result in legal conflicts or processing hold-ups.

Emphasis on Privacy and Data Security

In addition to its comprehensive verification process, Livesign gives a high priority on user privacy and data security. After the verification process is finished, the platform blurs private details, making sure that confidential information is not exposed or stored. In contrast to many other digital signing solutions, Livesign does not require clients to store private documents or identification data, minimising the risk of security breaches or identity theft.

This multi-step verification adds in security features so that unauthorised users cannot access signed documents or interfere with the confirmation of the signing process.

After the signing of the documents, Livesign makes sure that these documents are kept in a digital storage that can be conveniently accessed from any location at any time. This enhances the convenience of users retrieving signed documents for legal, business, or personal use.
